It was reported that the fences at Centennial Park will remain up through March because the grass didn't grow as fast as predicted due to cold weather and heavy rains. The Ohlone Greenway BART Station Access and Placemaking Improvements project is essentially complete and the City and contractor are going through punch list items. The City is also making repairs to the Castro and Canyon Trail Clubhouse roofs.
