RELEASE OF LIABILITY - HOLD HARMLESS AND INDEMNIFICATION AGREEMENT

In consideration for the opportunity to volunteer with the City of El Cerrito Green Teams Volunteer Program, I hereby acknowledge, agree, and represent as follows:

1. I am volunteering with the City of El Cerrito Green Teams Volunteer Program ("Program") within the City, which may include planting and trimming trees, picking up litter from parks and public areas, talking with and surveying residents or businesses, Earth Day and/or Green Team projects and other activities ("Activities"), and do so with full knowledge of the risks involved. I fully assume all risks to myself or others caused in any manner by any and all of my actions related to the Program and its Activities.
2. I fully understand that the risks of participating in the Program and its Activities can include, but are not limited to, loss or damage to equipment or property, bodily injury, illness, disease, permanent trauma, or death. I understand that my participation in the Activities is made at my own risk. I agree to assume full responsibility for myself (or my minor child, if applicable) for the risks identified herein, including those related to the COVID-19 pandemic, and those risks not specifically identified. I certify that I am fully capable of participating in the Program and related Activities.
3. On behalf of myself, my heirs, executors, administrators and assigns, I hereby waive, release and discharge any and all claims, demands, causes of action, lawsuits, allegations, or assertions for damages, death, personal injury, illness, disease, or any other compensable loss of any type that I (or my minor child, if applicable) may have, or that may hereafter accrue to me (or my minor child) as a result of my (or my minor child's) participation in the Program. This release is intended to discharge in advance the City and its officials, agents, instructors employees, and volunteers from and against any and all liabilities arising out of or connected in anyway to my participation (or my minor child's participation) in this event, even though that liability may arise from the City's negligence in organizing and planning of the Program. This includes any liability that may arise relating to any person contracting coronavirus disease (COVID-19), or alleging that a person contracted COVID-19, as a result of participating in the Program.
4. I agree to hold harmless and indemnify and defend the City and its officials, employees, agents, and representatives for, from, and against all claims, demands, causes of actions, lawsuits, allegations, or assertions of any nature, including but not limited to judgment, costs, attorney fees, legal expenses, penalties, arising either directly or indirectly or in any manner connected to my involvement and participation in the said Program, or the involvement of my agents, or of anyone related to me, including those arising from or relating to actual or alleged contracting of COVID-19 infection as a result of participating in the Program.
5. I agree to follow all applicable orders, guidance, guidelines and public health requirements issued by the City, the Contra Costa County Health Officer and the State of California, including the requirements within the City's "Social Distancing Protocol," and all other applicable requirements. By signing below, I acknowledge that I have received a copy of the Social Distancing Protocol and am familiar with its content.
6. I agree to have photographs, films, videotapes or tape recordings taken of me or the minor child registered under my signature while participating in the Program. I permit these photographs, films or tapes to be released: to be used in publications, promotional materials, web site and for other public information purposes by the City of El Cerrito.
